Сроки проведения работ с 19.05.2026 г. по 28.05.2026 г. Способ проведения работ: наземное применение. Наименование запланированных к применению пестицидов и агрохимикатов и классы их опасности:

Фунгицид Солигор, класс опасности для человека (опасный), класс опасности для пчел 3 (малоопасный), срок выхода ручных (механизированных работ) 3 суток.

Рекомендуемые сроки ограничения лета пчел – 24-48 часа.

Погранично защитная зона лета пчел: не менее 3-4 км.

Инсектицид Борей Нео, класс опасности для человека 3 (малоопасный), класс опасности для пчел 1 (высокоопасный), срок выхода ручных (механизированных работ) 3 суток.

Рекомендуемые сроки ограничения лета пчел – 4-6 суток

Погранично защитная зона лета пчел: не менее 4-5 км.
